## PRIVACY POLICY - VIDEO CONTEST DXT

on the processing of personal data for the publication and dissemination of the contents present in the Contest

Pursuant to art. of EU Regulation no. 679/2016 (hereinafter "GDPR"), containing provisions for the protection of people and other subjects with respect to the processing of personal data, we wish to inform you that the personal data provided by you will be processed in compliance with the aforementioned legislation.

The provision of your personal data is optional, however, refusal to provide such data will make it impossible to proceed with participation. The data is collected directly from the interested party. If the source of the data is not the interested party, they will be collected and communicated by third parties acting as independent data controllers.

#### 1) Data controller

## 2) Types of data collected

The personal data processed are:

- common data (e.g. name and surname, images, photos, audio and video)
- any particular data (e.g. personal data revealing racial or ethnic origin, religious or philosophical beliefs).

### 3) Purpose of the processing

Personal data will be processed for the following purposes:

- a) management and reproduction of images, films and/or voices through all the most suitable channels and means of communication with the right to process, reduce and/or adapt them, also for the purposes of reporting rights;
- b) fulfillment of legal obligations;
- c) disputes and possible disputes.

Furthermore, the contact data will be processed for the possible sending of communications via email (e.g. in the event of a win).

# 4) Legal basis of the processing

The legal basis of the processing is:

- the contract, where applicable, or the consent expressed by you for the purposes referred to in letter a);
- the fulfillment of legal obligations for the purposes referred to in letter b);
- the legitimate interest of the Data Controller for the purposes referred to in letter c).

## 5) Scope of circulation and dissemination of data

Participants acknowledge and accept, in consideration of the public nature and purpose of the Contest, that the data relating to their image may be made publicly accessible and/or communicated to third parties for the purposes of reporting, documentation and promotion of the Zoldo Athletics Events., as well as in the fulfillment of specific legal or regulatory obligations. The films will be disseminated through any type, way, medium and system of use, in any form, in whole or in part, even by re-editing them. The Data Controller uses and processes the data, also through its technical and service partners and companies connected to it and with the support of sponsors.

The interested party can find out the list of partners and sponsors at any time by contacting the Data Controller.

### 6) Communication and dissemination of data

Personal data will be processed exclusively by persons authorized to process (art. 29 GDPR) and by third parties expressly designated as Data Processors (art. 28 GDPR), in order to carry out all processing activities necessary to pursue the detailed purposes in this Policy.

## 7) Data retention

Personal data will be retained for the period necessary to achieve the purposes and in particular:

- for the period necessary for the exploitation of the material in accordance with the provisions of copyright law for the purposes referred to in letter a);
- for the period necessary to fulfill the legal obligation for the purposes referred to in letter b);
- for 10 years from the dispute or from its becoming final for the purposes referred to in letter c).

For the purposes of conservation and, more generally, processing, the Data Controller may use third parties under its own responsibility; these subjects, if the legal conditions are met, will be appointed Data Controllers pursuant to art. 28 of EU Regulation 679/2016.

### 8) Transfer of data outside the EU

Personal data will be processed by the Data Controller within the territory of the European Union.

If for technical and/or operational reasons it is necessary to make use of subjects located outside the European Union, we hereby inform you that the processing will take place in compliance with the rights and guarantees provided for by current legislation.

### 9) Rights of the interested party

At any time the participant will be able to exercise their rights regarding the processing of personal data pursuant to the articles. 15-22 of EU Regulation 679/2016. These rights concern:

- a. Access: the interested party can obtain information in relation to the processing of his data and a copy of such data.
- b. Rectification: where you believe that your data is inaccurate or incomplete, you may request that such data be modified accordingly.
- c. Cancellation: the interested party may request the deletion of the data if he revokes his previous consent and there is no other legal basis for the processing or in other cases provided for by law.
- d. Limitation: in the cases provided for by law (for example, if he disputes the legitimacy of the processing or the accuracy of the data), the interested party can obtain the limitation of the processing of the data without them being deleted.
- e. Opposition: the interested party may object to the processing of data if the processing is based on a legitimate interest of the Organizer for reasons related to his particular situation, unless there are compelling reasons why the interest of the Organizer prevails over his rights (this is the case, for example, in which the processing is necessary to defend a right of the Organizer in court).
- f. Revocation of consent: the interested party can revoke the consent previously given for the purposes of the processing. The interested party may, at any time, object to the processing of his/her data for commercial purposes and revoke the consent given. In accordance with current legislation, in addition to the above rights, the interested party also has the right to lodge a complaint with the Guarantor for the protection of personal data.
